TERMS AND CONDITIONS

- 1. In cases where an applicant knowingly gives misleading information and receives the concession, he/she shall become liable to pay the required duty with interest.
- 2. Only farms or farmers registered with the Rural Agricultural Development Authority (RADA) can apply for the concession.
- 3. Vehicles purchased with a concession cannot be sold within (3) three years of the date the concession was received. Also, the concession cannot be transferred for other type of activities outside of the concession privilege. Abuses will solicit suspension of the concession and the purchaser will become liable to pay the full duty.
- 4. The concession is only applicable to pick-ups less than 3,000 kg laden weight which are imported or purchased by registered farmers.
- 5. There is a limit to the number of vehicles which are eligible for the concessionary incentive in any given year.
- 6. The applicant to whom the concession is granted shall exercise continuous control over the vehicle for the aforementioned three (3) year period.
- 7. Control over the pick up shall not, within the aforementioned three (3) year period, be vested in a person other than the farmer by a Power of Attorney or any other method.
- 8. If the applicant is no longer engaged in the agricultural activity within three (3) years of the date of importation/purchase of the pick-up in respect of which a concession was granted, the full duties will become payable.

PROCEDURE

- (a) Complete the Application form which is available at all Rural Agricultural Development Authority (RADA) Parish Offices.
- (b) Submit it to the RADA Parish Office in the Parish in which the farm enterprise is located for verification and recommendation. Applications that **do not** meet the criteria **will be rejected at the Parish Level**.
- (c) The applicant will be informed by the local RADA Office of the decision taken.
